

Hands-On Training

Duration: 2 Weeks

Mock Training: Cash-handling, sanitizing facility, reviewing inventory manifests and identifying discrepancies, printing package labels, disposing and dispensing mock inventory, greeting patients, accepting and rejecting deliveries, audits, recalls, patient interactions, and emergencies "Soft" Opening: Employees will practice daily operational tasks, including dispensing mock cannabidiol

Employee Development

Occurrences: 90 days initially; every 6 months Additional Training: Safe handling of medical cannabidiol, common industry hazards, current health and safety standards, medical cannabidiol sales best practices, and legal updates

Maintaining a safe and secure facility:

- Controlled access areas accessible only by RFID chip technology in staff badge
- Security systems in place with remote-access video surveillance 24/7
- Panic buttons located throughout facility with direct access to law enforcement
- Storage vault access limited to dispensary manager and assistant dispensary manager
- Unsellable product cabinet access limited to dispensary manager and assistant dispensary manager
- "Active" inventory counted daily; Inventory audits completed weekly by dispensary manager

Opening Duties: 7:30am-8am

- Sellable products in storage vault separated into "active" and "back-stock" inventory
- "Active" inventory stocked to sales floor
- Educational reading material stocked
- Technology turned on and working correctly
- Cash reconciliation
- Cash counts

Closing Duties: 4:30pm-5pm

- Sellable products counted and verified through the inventory tracking system
- Sellable products organized and stored in storage vault
- Clean and sanitize facility
- Cash counts

- Follow Up Visits:
 Discuss safety and efficacy, alternative recommendations

Sales Area

- Triple verification completed on labels/medicine
- Patient information entered into patient tracking system
- Company cash-handling procedures will be followed
- Educational material available

HIV/AIDS		THC 2.5mg orally, starting in the evening	Avoid tinctures: - Certain HIV medications can interact with alcohol, - Mouth sores related to chemotherapy and radiation
Terminal Illness		2. CBD Dominant 5mg- 25mg orally after dinner	
Seizures	Convulsive or non- convulsive, cognitive impairment, difficulty focusing, fatigue, sleep disturbances	CBD dominant 2mg/lb (1mg/kg) divided twice daily Up to 100 mg/day Oral, sublingual or transdermal	Obtain baseline antiepileptic drug levels, when available, to identify potential drug interactions Separate medication administration by 1 to 3 hours when possible Additive cognitive impairment, sedation, dizziness and weakness.
