ARTICLE ONE. The name of this corporation is Iowans for Medical Marijuana. Iowans for Medical Marijuana is organized under the Iowa Nonprofit Corporation Act, Chapter 504A of the Code of Iowa.

ARTICLE TWO. The period of duration of this corporation is the have continuance forever and perpetual succession by the name of Iowans for Medical Marijuana.

ARTICLE THREE. The purposes for which this corporation is organized are: (A) to compile, maintain, and publish scientific information on the medical use of marijuana; (B) to compile, maintain, and publish information on the medical use of marijuana by individuals who are currently using marijuana for medical purposes; (C) to compile, maintain, and publish information concerning judicial interpretations of the laws regulating the medical use of marijuana; (D) to develop strategies and methods for the appropriate regulation of the medical use of marijuana; and (D) to educate the public regarding the medical use of marijuana.

ARTICLE FOUR. This corporation is not organized for a pecuniary profit. It will not have the power to issue certificates of stock or declare dividends, and no part of its net earnings will inure to the benefit of any member, director, or individual. The balance, if any, of all money received by the corporation from its operations, after the payment in full of all debts and obligations of the corporation of whatever kind or nature, will be used and distributed exclusively to Patients Out of Time, Fish Pond Plantation, 1472 Fish Pond Road, Howardsville, Virginia 24562, Telephone (434) 264-4484, Fax (434) 263-6753, Email [patients@medicalcannabis.com](mailto:patients@medicalcannabis.com), Website [www.medicalcannabis.com](http://www.medicalcannabis.com). Patients Out of Time is a non-profit corporation registered in the State of Virginia and is tax exempt under Internal Revenue Service Code 501(c)(3).

ARTICLE SIX. The corporation will have three initial directors: (A) Carl Eric Olsen, 130 East Aurora Avenue, Des Moines, Iowa 50313-3654; (B) George McMahon, Livermore, Iowa; and (C) Barbara Douglass, 910 Lakeshore Drive, Lakeside, Iowa 50588-7672.

ARTICLE SEVEN. The conditions and regulations of membership and the rights and other privileges of the classes of membership will be determined and fixed by the bylaws.

ARTICLE EIGHT. The private property of the members of this corporation will not be liable for its corporate debts.

ARTICLE NINE. This corporation will never mortgage or place a deed of trust or other lien on any of its properties for any purpose, nor will it, save for current expenses, incur indebtedness at any time during its existence.

ARTICLE TEN. Notwithstanding any other provision of these articles, the corporation will not carry on any other activities not permitted to be carried on; (A) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Code section); or (B) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Code section).

ARTICLE ELEVEN. Notwithstanding any other provision of these articles, this corporation will not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE TWELVE. No substantial part of the activities of the corporation will be devoted to the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation will not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
