DECLARATION OF TAYLOR FAIRMAN

- I, Taylor Fairman, do hereby attest as follows:
- 1. I am over the age of majority, am competent to testify, and I have personal knowledge of the matters addressed in this declaration.
- 2. This Declaration is submitted in support of Plaintiffs' Supplemental Brief in Support of Their Motion for Preliminary Injunction.

- 3. I am the one of the founders of TCI Enterprises, Inc. d/b/a Sky High, which sells products that Iowa has defined as "consumable hemp products." I got involved in the consumable hemp industry when my two-year-old daughter was diagnosed with cancer.
- 4. Sky High was established on February 2, 2021, and was the first licensed company marketing THC products within Iowa and registered with Iowa's consumable hemp program.
- 5. Sky High is registered with the Iowa Department of Health and Human Services ("DHHS") as a Retail Consumable Hemp Facility and a Manufacturing Consumable Hemp Facility, and the consumable hemp products previously sold at Sky High were approved by DHHS.
- 6. After July 1, 2024, all of Sky High's previously approved products that were specifically manufactured based on the FAQ guidance were removed from Sky High's Consumable Hemp Registration Portal.
- 7. If I go into the DHHS portal and click "export template," it will show the products that I have uploaded. A true and correct copy of the webpage as of July 12, 2024, when I do this action on DHHS' website for Sky High is attached as Exhibit "1."
- 8. However, that same day, I tried to view Sky High's current product list that could be marketed and sold in Iowa and it shows, "no products pending or approved for this facility at this time." A true and correct copy of the webpage as of July 12, 2024, when I do this action on DHHS' website for Sky High is attached as Exhibit "2."
- 9. Since the filing of this lawsuit, my contact at DHHS, Bobby Barcelo, the Program Manager for Consumable Hemp within Iowa, has informed me verbally that no products would be approved or denied until the draft regulations are made effective or this Court rules on the

pending preliminary injunction motion. Consequently, Sky High's products are in a limbo state until this matter is addressed by the Court.

- 10. The regulatory delay and uncertainty have caused tremendous confusion, especially as a manufacturer of products who has to invest thousands of dollars in molds for gummies and additional product development before any products are formally approved by DHHS. The industry needs clarity as soon as possible.
 - 11. I declare under penalty of perjury that the foregoing is true and correct.
